Bring the cat's/cats' pedigree/registration form, a valid vaccination form (as per SVERAK's rules), and the show registration confirmation from our cat club (NOS). These may need to be presented during check-in.

Spot health checks by the veterinarians will be conducted on both Saturday and Sunday. All vaccinations will be checked.
